



Fee Schedule of the Industrial Association for Repowering, Dismantling and Recycling of Wind Turbines (RDRWind e.V.)

As of: 7 December 2018; amended on 31 January 2019

In accordance with Article 6 of RDRWind e.V.'s Articles of Association and the resolution of the Founding Members' Meeting dated 7 December 2018 and the resolution of the General Assembly dated 30 January 2019.

1. Membership

Membership of RDRWind e.V. is based on the respective calendar year. Members of RDRWind e.V. shall pay annual membership fees, which are levied in accordance with the RDRWind e.V membership fee structure.

2. Annual fees and modalities

The annual membership fee will be charged in January 2019 for the first time. The annual membership fee is collected annually thereafter. Members, who join RDRWind e.V. before 1 July shall pay the fee for the full year. Registrations after this date shall be invoiced on a monthly basis.

Membership fee for companies is based on the number of employees in the company:

3. Non-profit companies and associations - annual fees

These only pay 50 % of the annual fee indicated above.

4. Sponsoring members of the association

Natural and legal persons can become sponsoring members of the association. Their sponsorship amount exceeds the above-mentioned contribution rates. Sponsoring members are named on the RDRWind e.V. website under the heading "Sponsoring members".

5. Private individuals - Annual fees

Private individuals pay the following fees as part of their RDRWind e.V. membership:

Annual fee: €60

Reduced annual fee:

€40 (pensioners and students etc.). A valid certificate is required as proof.

Private members cannot avail themselves of consultancy services provided by the association or participate in the boards of RDRWind e.V.

6. Discounted member services within the framework of RDRWind e.V. can be used from the day of joining.

7. Advisory boards and optional contribution regulations for Advisory Board Members.

Members registered with RDRWind e.V. (except for private members) have access to boards or other working forums for the exchange of experience and information. Members are admitted to the boards based on a written application to the board.

The boards elect a spokesperson by simple majority for a term of 2 years.

In accordance with RDRWind e.V. Articles of Association, the *optional* contribution scheme is discussed and approved by the board.

Optional membership fees for the boards

The prerequisite for participation in the advisory boards is the payment of the respective fee (if provided for) and a resolution by the Advisory Board on the admission of the relevant member to the Advisory Board.

Exception: No additional fees for the R&D Advisory Board.

No fee is charged.

Exception: No additional fees for the Association Development Advisory Board.

No fee is charged.
